Pool Upper Deck

Rolling Rock Club Policies

Electronic Devices

Rolling Rock Club recognizes that handheld, electronic devices are a part of everyday life and incertain situations can allow members and their families to enjoy their Club with greater enjoymentand peace of mind. Members need to use discretion when using any electronic device to ensure the privacy of other Members. Nonetheless, some restrictions apply.

Fitness Center, Shooting Lodge, Swimming Pool and Tennis Courts Policy

The use of handheld, electronic devices for discreet, non-verbal communication is allowed at theFitness Center, Swimming Pool and Tennis Court areas; however, all such devices must be on “silent” mode at all times. Placing or receiving a call on an electronic device is permitted only in a closed vehicle in the Swimming Pool or Shooting Lodge parking lots. Location “tagging” is not allowed.

Clubhouse Policy

The use of handheld, electronic devices for cellular calls in the Clubhouse, Golf Course andsurrounding grounds is prohibited except for guest rooms, guest houses, meeting rooms, phone booths or in parked cars. The non-disruptive use of electronic devices for reading only is permitted inpublic areas during the day until 5:00 p.m. Please no texting or emailing. All devices must be on“silent” mode at all times. Using electronic devices for reading is never permitted in the Log Bar,dining areas or the terraces. Using a cell phone as a camera is restricted to private events with theapproval of the host member and only in areas being utilized for such private events. Location “tagging” is not allowed.

Members are responsible for their guest’s knowledge of and compliance with the Electronic Device Policy.

No tipping is permitted for any service performed by a Club employee. Instead, a service charge will be added to all bills. Car parkers at Club parties and massage therapists are not considered Clubemployees and may accept tips..

Smoking is permitted in the Tower Bar only. Smoking is prohibited in the Cabin, Herdsman’sCottage, Quail Cottage, Shooting Lodge, throughout the Clubhouse and on the Outside Terraces. Whensmoking in permitted, outside areas, Members and their guests should exercise discretion when the risk exists of exposing other members, guests or employees to second-hand smoke.
